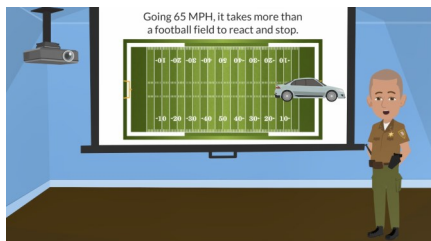


NEW! 2021 TMEC Instructor Trainings



What is TMEC? The Tobacco Marijuana & E-Cigarettes Course (TMEC) was developed by Certified Prevention Specialists in partnership with schools, law enforcement, treatment and medical providers in Oregon to educate youth and adults (ages 13 and above) about the consequences of substance use and impaired driving. TMEC was piloted in collaboration with Redmond School District and High Desert ESD Driver Education Programs in 2016, launched statewide in 2017, revised in 2019, and revamped as an animated video curriculum in 2021.

What's new? CLEAR Alliance updated and released an animated 2021 revision of the 3-hour TMEC curriculum, and created a 90-minute Impaired Driving Education Course (IDEC).



Who is licensed to teach TMEC or IDEC? Verified youth-serving agencies, Schools, Educators, Driver Education Programs, Law Enforcement Agencies, DREs, SROs, Prevention Coordinators, Treatment Providers, Medical Staff, Church Leaders, Parent Leaders, and Teen Leaders.

How do I register and pay? If you have already purchased a license to teach TMEC or IDEC, the instructor training is included. If you prefer to attend the instructor training first before determining if your agency will be licensed, the cost is \$50 per person.
